

Assyria Township Board Minutes
September 5, 2023

A regular meeting of the Assyria Township Board was held at the Assyria Township Hall, September 5, 2023. The meeting was called to order at 7:30 p.m. and the Pledge of Allegiance was recited.

Public Comment:

Sandy Schilz inquired if anyone had heard of a large solar panel project to be started in the near future.

Webmaster, Parri Gignac, gave her report.

County Commissioner: Gave his report.

Drain Commissioner: Confirmed the township would be able to pay the financed funds for their assessment of the drain project early, which would save the township approximately \$35,000.00 to \$40,000.00 in additional interest charges. J. Miller made a motion to pay the assessment early. The board decided to table the motion until all board members were present.

Motion made by A. Terry, supported by T. Wing to approve the minutes.
J. Miller found a missing "r" from the word Treasurer and Scot Higgins requested the last two sentences regarding the checks be removed from the minutes.
